NB: Please note that if you do not manage to obtain 60 credits at the end of the first year (level 4), you will need to retake the entire first year. This will incur an additional full, first-year fee.

Failure to observe regular fee payments may lead to the immediate termination of student status.

Refunds

Residence Permit Issues

If a student who has applied for a residence permit from his/her home country is not granted a residence permit before the induction, the deposited tuition fee, less a DKK 2,000 administration fee, will be refunded.

If a student who has applied for a residence permit from Denmark is not granted a residence permit two months after the induction, the deposited tuition fee, less a DKK 2,000 administration fee, will be refunded.

Any refund request must be submitted at the latest 60 days after study start. In case the student does not file a refund request she/he is not eligible for a refund of the deposited tuition fee.

No-show students

No-show students who do not submit notice are not eligible for a refund of the deposited tuition fee.

Withdrawal prior to study start

Students who fail to attend Induction (no-show students) will automatically be withdrawn from the programme unless the student has previously informed Niels Brock Copenhagen Business College in writing of the reason for not attending.

Refunds will only be given to students who have given written notice to <u>international@brock.dk</u> 40 calendar days prior to Induction.

Withdrawal after study start

There is no refund for students terminating their enrolment after the beginning of the semester.

Termination

Students wishing to terminate their studies prior to each semester must notify the administration in writing to <u>international@brock.dk</u> 30 calendar days prior to the first payment deadline date of each semester. If no written notice is received by that date the student is liable for payment of that semester's full fee.

If a student's studies are terminated due to academic misconduct, absence or other offences, they are not eligible for a refund of the deposited tuition fees.
